
**विषय: Teaching of Sanskrit in Class XI – reg.**

महोदय/महोदया,

This office had communicated vide letter no. F.11029-10/2012-14/KVS(HQ)Acad. dated 05.12.2014 that Sanskrit(Core) can be offered as one of the languages in class XI from the session 2015-16, since the provision already exists in the Scheme of Studies of KVS (Refer Article 108 of Education Code). However, when the relevant data was collected from all the regions, it was observed that only a few students from Bangalore and Ernakulam regions have opted for the same in 2015-16. It is surmised that the students are not opting for Sanskrit in class XI, since PGT(Skt.) are not available and as per the provisions of the Education Code for KVS, a teacher can be appointed on contract only if at least 15 students opt to study the subject.

With a view to promote study of Sanskrit at +2 level, it has been decided that all KVs, where students are presently studying Sanskrit in class X, should conduct interviews for PGT (Sanskrit) on contractual basis with the presumption that those students will wish to study Sanskrit in class XI too. A panel for PGT (Sanskrit) should be kept ready so that if adequate number of students opt for Sanskrit in class XI, the PGT (Sanskrit) can be appointed on contractual basis in the KV concerned immediately. These KVs should also be instructed to take adequate measures to create awareness amongst students regarding the arrangements made for teaching of Sanskrit in class XI so that the apprehensions arising from non-availability of Sanskrit teacher for class XI are laid to rest and students are motivated to opt for Sanskrit at the +2 level.
