

**Empanelment of Jammu Hospital, Kapurthala Road, Jalandhar (Punjab), Pin - 144 001 for treatment of Central Government employees under CS (MA) Rules, 1944**

The undersigned is directed to say that the proposal received for empanelment of Jammu Hospital, Kapurthala Road, Jalandhar (Punjab), PIN-144 001 for treatment of Central Government Employees and their family members under CS(MA) Rules, 1944 was under consideration for some time.

2. In view of the hardship faced by CS (MA) beneficiaries for their own treatment and the treatment of their family members at Jalandhar (Punjab), the matter has been examined in the Ministry and it has been decided to empanel Jammu Hospital, Kapurthala Road, Jalandhar (Punjab) under Central Services (Medical Attendance) Rules, 1944.

3. The Schedule of charges for the treatment of Central Government Employees and the members of their family under the CS (MA) Rules, 1944, will be the rates fixed for CGHS, Chandigarh. The approved rates are available on the website of CGHS (<http://msotransparent.nic.in/cghsnew/index.asp>) and may be downloaded/printed.

4. The undersigned is further directed to clarify as under:—

(a) "Package Rate" shall mean and include lumpsum cost of in-patient treatment / day care / diagnostic procedure for which a CS (MA) beneficiary has been permitted by the competent authority or for treatment under emergency from the time of admission to the time of discharge, including (but not limited to)-(i) Registration charges, (ii) Admission charges, (iii) Accommodation charges including patient's diet, (iv) Operation charges, (v) Injection charges, (vi) Dressing charges, (vii) Doctor / consultant visit charges, (viii) ICU / ICCU charges, (ix) Monitoring charges, (x) Transfusion charges, (xi) Anaesthesia charges, (xii) Operation theatre charges, (xiii) Procedural charges / Surgeon's fee, (xiv) Cost of surgical disposables and all sundries used during hospitalization, (xv) Cost of medicines, (xvi) Related routine and essential investigations, (xvii) Physiotherapy charges etc, (xviii) Nursing care and charges for its services.

(b) Cost of Implants is reimbursable in addition to package rates as per CGHS ceiling rates for implants.

(c) Treatment charges for new born baby are separately reimbursable in addition to delivery charges for mother.

(d) Jammu Hospital, Jalandhar (Punjab) shall not charge more than the package rates fixed for CGHS, Chandigarh.

(e) Expenses on toiletries, cosmetics, telephone bills, etc. are not reimbursable and are not included in package rates.

5. Package rates envisage duration of indoor treatment as follows:—

- Up to 12 days : for Specialized (Super Specialities) treatment
- Up to 7 days : for other Major Surgeries
- Up to 3 days : for Laparoscopic surgeries / normal Deliveries
- 1 day : for day care / Minor (OPD) surgeries.

No additional charge on account of extended period of stay shall be allowed if that extension is due to infection on the consequences of surgical procedure or due to any improper procedure and is not justified.

In case, there are no CGHS prescribed rates for any test / procedure, then AIIMS rates are applicable. If there are no AIIMS rates, then reimbursement is to be arrived at by calculating admissible amount item-wise (e.g. room rent, investigations, cost of medicines, procedure charges, etc.) as per approved rates / actually, in case of investigations.

6. (a) CS (MA) beneficiaries are entitled to facilities of private, semi-private or general ward depending on their basic pay. The entitlement is as follows:—

S. No.	Pay drawn in pay band	Ward Entitlement
1.	Up to ₹ 13,950	General Ward
2.	₹ 13,960 to 19,530	Semi-Private Ward
3.	₹ 19,540 and above	Private Ward

(b) The package rates given in rate list are for semi-private ward.

(c) The package rates prescribed are for semi-private ward. If the beneficiary is entitled for general ward there will be a decrease of 10% in the rates; for private ward entitlement there will be an increase of 15%. However, the rates shall be same for investigation irrespective of entitlement, whether the patient is admitted or not and the test, *per se*, does not require admission.

7. The hospital shall charge from the beneficiary as per the CGHS prescribed rates or its own rate list, whichever is lower. The hospital shall charge CGHS Non-NABH Chandigarh rates.

8. (a) The maximum room rent admissible for different categories would be:

General ward	₹ 1,000 per day
Semi-private ward	₹ 2,000 per day
Private ward	₹ 3,000 per day
Day care (6 to 8 Hrs.)	₹ 500 (same for all categories)

(b) Room rent mentioned above at (a) above is applicable only for treatment procedures for which there is no CGHS prescribed package rate.

Room rent will include charges for occupation of bed, diet for the patient, charges for water and electricity supply, linen charges, nursing charges and routine up keeping.

(c) During the treatment in ICCU / ICU, no separate room rent will be admissible.

(d) Private ward is defined as a hospital room where single patient is accommodated and which has an attached toilet (lavatory and bath). The room should have furnishings like wardrobe, dressing table, bed-side table, sofa set, etc. as well as a bed for attendant. The room has to be air-conditioned.

(e) Semi Private ward is defined as a hospital room where two to three patients are accommodated and which has attached toilet facilities and necessary furnishings.

(f) General ward is defined as hall that accommodates four to ten patients.

(g) Normally the treatment in higher category of accommodation than the entitled category is not permissible. However, in case of an emergency when the entitled category accommodation is not available, admission in the immediate higher category may be allowed till the entitled category accommodation becomes available. However, if a particular hospital does not have the ward as per entitlement of beneficiary, then the hospital can only bill as per entitlement of the beneficiary even though the treatment was given in higher type of ward.

If, on the request of the beneficiary, treatment is provided in a higher category of ward, then the expenditure over and above entitlement will have to be borne by the beneficiary.

9. In case of non-emergencies, the beneficiary shall have the option of availing specific treatment / investigation from any of the above mention hospitals of his/her choice (provided the hospital is recognized for that treatment procedure / test), after the specific treatment / investigation has been advised by Authorized Medical Attendant and on production of valid ID card and permission letter from his/her concerned Ministry / Department.

10. The hospital shall honour permission letter issued by competent authority and provide treatment / investigation facilities as specified in the permission letter.

11. The hospital shall also provide treatment / investigation facilities to the CGHS beneficiaries and their eligible dependent family members at their own rates or rates approved under CS (MA) Rules, whichever is lower. The hospital shall provide treatment to such pensioner CGHS beneficiaries after authentication through verification of valid CGHS Cards.

12. However, pensioner CGHS beneficiaries would make payment for the medical treatment at approved rates as mentioned above and submit the medical reimbursement claim to the Additional Director, CGHS through the CMO in charge of the CGHS Wellness Centre, where the CGHS Card of the beneficiary is registered.

13. In case of emergencies, the beneficiary shall have the option of availing specific treatment / investigation from any of the above mentioned hospitals of his/her choice (provided the hospital is recognized for that treatment procedure / test), on production of valid ID card, issued by competent authority.

14. During the in-patient treatment of the CS (MA) beneficiary, the hospital will not ask the beneficiary or his attendant to purchase separately the medicines / sundries / equipment or accessories from outside and will provide the treatment within the package rate, fixed by the CGHS which includes the cost of all the items.

15. In case of treatment taken in emergency in any non-recognized private hospitals, reimbursement shall be considered by competent authority at CGHS prescribed Package / rates only.

16. If one or more minor procedures form part of a major treatment procedure, then package charges would be permissible for major procedure and only 50% of charges for minor procedure.

17. Further, the Jammu Hospital, Kapurthala Road, Jalandhar shall undertake the investigations / diagnostic tests / consultations / examinations as a service provider for conducting the Annual Medical Examination of the Central Government Civil Services Group 'A' Officers of above 40 years of age as per the prescribed protocol for Annual Medical Examination. The hospital shall conduct all prescribed investigations / diagnostic tests / consultations / examinations, etc. of the Group 'A' Central Government Officers according to the prescribed protocol as per **Annexure (not received)**.

18. The hospital, will not charge the Central Government Employees more than ₹ 2,000 for conducting the prescribed medical examinations of the male officers and ₹ 2,200 for female officers, who come to the hospital with the requisite permission letter from their Department / Ministry concerned. The above rates for Annual Medical Examination are valid until such time when the above rates are revised by the Central Government.

19. Any legal liability arising out of such services shall be the sole responsibility and shall be dealt with by the concerned empanelled hospital. Services will be provided by the Hospital as per the terms given above.

20. Ministry of Health and Family Welfare reserves the right to withdraw / cancel the above recognition without assigning any reason.

21. The order takes effect from the date of issue of the O.M.

22. The authorities Jammu Hospital, Kapurthala Road, Jalandhar (Punjab) will have to enter into an agreement with the Government of India to the effect that the Hospital will charge from the Central Government employees at the rates fixed by the Government and they will have to sign a Memorandum of Understanding (MoU) (2 copies enclosed only for Hospital — not printed) within a period of 3 months from the date of issue of the above mentioned OM failing which the Hospital will be derecognized. Subject to above, the Hospital can start treating Central Government employees covered under CS (MA) Rules, 1944.

**Suspension of empanelment of  
Dr. Khanna's Path Care Pvt. Ltd., Delhi**

With reference to the above-mentioned matter, the undersigned is directed to draw attention to the Office Memorandum of even number, *vide* which **Dr. Khanna's Path Care Pvt. Ltd., A-43, Hauz Khas, New Delhi - 110 016** was empanelled under CGHS and to state that **Dr. Khanna's Path Care Pvt. Ltd., Delhi** had violated the terms and conditions of MoA signed with CGHS by indulging in fraudulent practices. A show-cause notice was issued to the laboratory and reply received was found to be unsatisfactory.

In view of this, it has been decided to suspend empanelment of **Dr. Khanna's Path Care Pvt. Ltd.** from CGHS for a period of three (3) months or till further orders, whichever is earlier from the date of issue of this order.

**Fresh Empanelment of Private Healthcare Organizations (HCOs)  
and revision of package rates applicable under CGHS, Bhopal**

The undersigned is directed to invite reference to this Ministry's Order No. 11045/36/2012/CGHS/HEC, dated 22-1-2014 *vide* which Director, Central Government Health Scheme invited e-bids through e-procurement from eligible private hospitals, exclusive Eye hospitals, exclusively Dental clinics, Cancer hospitals, Diagnostic and Imaging Centre (including those already empanelled) for determination of rates to be fixed for empanelled Private Health Care Organization for various approved treatment procedure / Investigation under CGHS to be provided to CGHS beneficiaries and for empanelment under CGHS. Accordingly, after following due process a list of private hospitals, eye care centres, diagnostic centres and imaging centres have been finalized as per the terms and conditions laid down in the above referred order as well as signing of Memorandum of Agreement and execution of Performance Bank Guarantee by them signifying acceptance of the terms and condition of empanelment and revised rates notified for CGHS Bhopal in 2014.

**Clarification regarding issue of medicines under CGHS**

With reference to the above-mentioned subject, the undersigned is directed to state that the situation arising out of issue of Office Memorandum No.2-2/2014/CGHS(HQ)/PPTY/CGHS(P) dated the 25<sup>th</sup> August, 2014 has been engaging the attention of Government for quite some time. Various representations about the difficulties being encountered have been received from different stake-holders i.e., beneficiaries and doctors, necessitating a review of the matter. It was accordingly considered by a Committee under the Chairmanship of AS&DG, CGHS. After careful review and keeping the recommendations of the Committee in mind, the following guidelines are issued to streamline the functioning of the Wellness Centres:-

- (i) The medicines are to be issued as per the CGHS Formulary and guidelines issued by the Ministry in this behalf.
- (ii) In case the prescribed medicines are not available in CGHS formulary, but are essential for the treatment of the patient, they can be issued/indented by the doctors of the CGHS Wellness Centre on the basis of a valid prescription of the authorized specialist subject to the condition that such medicines are neither dietary supplements/food items nor banned drugs. Instructions on this issue i.e., non-admissibility of food items etc. issued vide O.M.No.39-3/2003-04/CGHS/MSD/RS, dated the 23<sup>rd</sup> July 2009 and 3<sup>rd</sup> August 2009 must be followed.
- (iii) In case of anti-cancer drugs and other life-savings drugs that are not approved by the DCGI for use in India, each case should be considered by the Expert Committee under the Chairmanship of Special DG (DGHS).
- (iv) The technical Standing Committee constituted vide 2-2/2014/CGHS(HQ)/PPTY/CGHS(P), dated 27-8-2014 of this Ministry will review addition or deletion of drugs in the CGHS Formulary/list of treatment procedures/investigations/listed implants. The Technical Committee will meet once in three months or as per need, whichever is earlier. In the meantime, re-imburement for unlisted procedures/implants will be made at the rates approved by AIIMS/GB Pant Hospital/actual, whichever is less.

**Delegation of power to HODs for permission / *ex post facto*  
permission treatment from private / empanelled hospital**

The undersigned is directed to state that CGHS guidelines have been issued whereby powers have been delegated for settlement of medical reimbursement claims (MRCs) incurred by CGHS beneficiaries with the primary objective of speedy settlement of medical claims.

2. Despite various instructions on settlement of MRCs, cases continue to come to MoH & FW seeking clarification sought on CGHS policy, relaxation of rules - procedural lapse / non-emergency treatment in non-empanelled hospitals, etc. This leads to extra work in this Ministry, and causes difficulties to the beneficiaries due to the delay in settlement of the claims. Accordingly, it has been decided to further decentralize the powers for settlement of medical claims to individual Ministries / Departments / Lok Sabha and Rajya Sabha Secretariat and to the Secretary General of Supreme Court (as the case may be) as under:—

### **Amendment to Fundamental Rules**

**GSR 6 (E).**— In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the President hereby makes the following rules further to amend the Fundamental Rules, 1922, namely:—

1. (1) These rules may be called the Fundamental (Amendment) Rules, 2014.
- (2) They shall be deemed to have come into force on the 27th October, 2013.

2. In the Fundamental Rules, 1922, in Rule 29, for Clause (2), the following clause shall be *substituted*, namely:—

“(2) If a Government servant is reduced as a measure of penalty to a lower service, grade or post or to a lower time-scale, the authority ordering the reduction shall specify,—

- (a) the period for which the reduction shall be effective;
- (b) whether, on restoration, the period of reduction shall operate to postpone future increments and, if so, to what extent; and
- (c) whether the Government servant shall regain his original seniority in the higher service, grade or post or time-scale on his restoration to the service, grade or post or time-scale from which he was reduced.”

### **EXPLANATORY MEMORANDUM**

In the Fundamental (Amendment) Rules, 2013 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), *vide* number GSR 263 (E), dated the 27th October, 2013, sub-clause (c) of Clause (2) of Rule 29 of the Fundamental Rules, 1922 was wrongly mentioned as Clause (3) to that rule. Necessary amendment is required to be made retrospectively from the date of notification of the said rules. It is certified that none will be adversely affected by giving retrospective effect to the amendment.

**Posting of Government employees who have differently  
abled dependants**

The undersigned is directed to refer to this Department's OM of even number, dated 6-6-2014 exempting a Government employee, who is also a caregiver of disabled child, from the routine exercise of transfer/rotational transfer subject to the administrative constraints. The word 'disabled' includes (i)blindness or low vision (ii)hearing impairment(iii)locomotor disability or Cerebral Palsy(iv)leprosy cured (v) mental retardation (vi)mental illness and (vii)multiple disabilities.

2. The matter regarding the scope of 'disabled' has been examined in consultation with the Department of disability Affairs. Considering the fact that the autism spectrum disorder child requires constant caregiver support and it would be imperative for the Government employees to take care of their autism spectrum disorder child on continuous basis, it has been decided to include 'Autism' in the term 'disabled', as defined in Para.3 of the above-mentioned OM, dated 6-6-2014.

3. This issues with the approval of the MoS (PP).

4. All the Ministries/Departments, etc. are requested to bring these instructions to the notice of all concerned under their control.

### **Introduction of AADHAR Enabled Bio-metric Attendance System**

It has been decided to use an AADHAR Enabled Bio-metric Attendance System (AEBAS) in all offices of the Central Government including attached / subordinate Offices, in India. The system will be installed in the offices located in Delhi / New Delhi by 31<sup>st</sup> December, 2014. In other places this may be installed by 26<sup>th</sup> January, 2015.

2. The equipment will be procured by the Ministries / Departments as per specifications of DeitY on DGS&D Rate Contract from authorized vendors. The expenditure will be met by the Ministries / Departments concerned under their O.E. The manual system of attendance may be phased out accordingly.

3. The Department of Electronics and Information Technology (DeitY) will provide the technical guidance for installing the system. The equipment already procured by DeitY have a built-in AMC of three years. The Ministries / Departments may ensure that the equipment being procured by them have similar provision.

4. Biometric attendance system is only an enabling platform. There is no change in the instructions relating to office hours, late attendance, etc. which will continue to apply. As per extant instructions, (contained in DoP&T, O.M. No. 28034/8/75- Estt-A, dated 4-7-1975; No. 28034/10/75- Estt. A, dated 27-8-1975; No. 28034/3/82-Estt. A, dated 5-3-1982) half-a-day's Casual Leave should be debited for each day of late attendance, but late attendance up to an hour, on not more than two occasions in a month, and for justifiable reasons may be condoned by the competent authority, in addition to debiting Casual Leave (or Earned Leave, when no CL is available). Disciplinary action may also be taken against Government servants who are habitually late. Early leaving is also to be treated in the same manner as late coming.

5. These orders come into force with immediate effect.

6. All Ministries / Departments are requested to bring this to the notice of all concerned.
