**विषय:** TRAINING AND SUMPTUARY ALLOWANCES TO THE DIRECTOR AND OTHER FACULTY MEMBERS POSTED AT THE ZONAL INSTITUTES OF EDUCATION & TRAINING OF KVS- REGARDING.

In light of the above references, it has been decided by the competent authority on the basis of Government of India orders that the Training Allowances and Sumptuary allowances to the Director and Other Faculty Members posted at the ZIETs of KVS shall be regulated in the following manner:

1. **Sumptuary Allowance** in all the Training Establishments / Academies/Institutes stands abolished w.e.f. 1<sup>st</sup> July, 2017.

2. **Training Allowance:**

(i)

In the National/Central Training Academies and Institutes for Group 'A' Officers	24% of Basic Pay.	Ceiling of 5 years period to be removed.
In other Training Establishments	12% of Basic Pay	Standard cooling off period between tenures will apply.

- (ii) **Training Allowance** will be admissible only to the employees who join the training establishments for a specified period of time and are then likely to go back.

- (iii) **Training Allowance** will not be admissible to those employees who are directly recruited by such training establishments for imparting training.

- (iv) **The revised rates of training allowance shall be admissible with effect from 1<sup>st</sup> July, 2017.**

The other contents of the letter of even no. dated 14/21-10-2011 remain the same.
